

Society Board of Trustee Nominations

The Society of Claim Law Associates is governed by a Board of Trustees consisting of seven members. Of these seven Trustees, one Trustee is appointed by the President of American Educational Institute and one is the Immediate Past President of the Society. These two Trustees are not elected. The Executive Director of the Society is a non-voting member of the Board of Trustees, also appointed by the President of AEI and serves as Board Secretary. The remaining four Trustees must be elected by the general membership for a two-year term that begins January 2025 and ends January 2027. Once elected, the Trustees choose from among themselves who shall serve as national President, Executive Vice President, Vice President of Administration, and Treasurer.

All nominees must have achieved the Senior Claim Law Associate (SCLA) designation by the nomination deadline, November 4th, to be eligible. To self-nominate or nominate a colleague, please complete the online application using the link below. The application will ask you to simply express your or the nominee's interest in serving, and provide a brief career history including your or the nominee's present employment (company and position), professional designations (e.g., SCLA), and all appropriate contact information. The application period closes on Monday, November 4, 2024 at 5p.m. (EST).

The Nominations Committee will then evaluate all interested candidates and make its recommendations for the slate of candidates to be voted on in December. For additional information contact: SCLA@aeiclaimslaw.com.

New Digital Badge for Silver & Gold Award!

In September 2022 all new SCLA designees began receiving a digital badge to highlight their accomplishment, digitally replacing the desktop pyramid. We are excited that SCLA Silver and Gold Award recipients will be provided with a digital badge instead of a desktop pyramid.

With the new realities of work-from-home, shared office space, and electronic communications, the digital badge identifies designees as an accomplished claims law professional and allows them to share their significant achievement with colleagues and contacts electronically. The badge verifies your designation in a simple and trusted way in real time and can be shared via an email signature and social media.

All new SCLA Silver and Gold award recipients will receive an email from AEI and then from Credly (our digital badge vendor) explaining how to activate the badge. It's important you activate within 30 days otherwise the badge will expire. Once activated, the badge will have no expiration date.

<u>Prior Designees! Digital Badges Available for Small Fee</u>: SCLA designees prior to September 2022 and SCLA Silver and Gold Award recipients prior to December 31, 2023 can purchase a badge for a one-time fee of \$10, click <u>here</u> for downloadable form and frequently asked questions.

<u>Attention Current Digital Badge Holders</u>: If you currently have an activated SCLA digital badge, the Silver or Gold Award badge will replace the SCLA badge. Only one badge will be provided for the highest achievement.
